

NUTRITION

Monitoring and Promotion of good Nutrition among the general populace of Sunyani is one of the main focuses of Sunyani Municipal Assembly (SMA). Nutrition is tasked with the responsibility of monitoring, supervising, implementing nutrition related activities as well as ensuring the nutritional wellbeing of the populace of Sunyani Municipality and beyond. It is also tasked with the responsibility of influencing the knowledge, attitudes and practices (KAPS) of the people of Sunyani Municipality on good nutrition related policies and interventions through advocacy, Behavioral Change communication (BCC) and enforcement of rules and regulations on food hygiene.

The current nutrition interventions implemented in the Municipality are: Laboratory Screening for all food handlers, Orientation for all food, drinks, and beverages handlers. Monitoring activities of all School feeding contractors in the Municipality, community based growth monitoring and promotion for children under five years, vitamin A supplementation for children 6 to 59 months and girl iron folic tablets supplementation (GIFTS) for adolescents girls, Iron Deficiency Anemia (IDA) prevention and control in pregnancy, Nutrition Friendly School initiative (NFSI) for school aged children, Food Security and Nutrition Monitoring System (FSNMS) and nutritional counseling for children under five years /pregnant women / on communicable and non-communicable diseases (hypertension, diabetes, etc)

NUTRITION ORIENTED INTERVENTIONS

- 1) Orientation for food and drinks handlers and caterers
- 2) Training sessions on good nutrition for school feeding contractors/caterers
- 3) Laboratory screening for all food handlers
- 4) Training and supervision of School Feeding contractors
- 5) Follow-up monitoring and enforcement of the laws on food and nutrition
- 6) Nutrition Interventions for school going children
 - A. Growth Monitoring
 - B. GIFTS (Girls Iron Folates Tablets Supplementation)
 - C. Vitamin A supplementation
- 7) Activities under each intervention

- I. Growth Monitoring – Anthropometric measurements of children under 5 years.
- II. GIFTS – Administration of Iron-Folates to girls 10-19 years weekly.
- III. Vitamin A Supplementation – Administration of Vitamin A to children from 6 months – 59 months.

ORIENTATIONS FOR SCHOOL FEEDING CONTRACTORS, FOOD VENDORS, FRUIT SELLERS AND BUTCHERS

During the period, six orientations were organized for Five hundred and Thirty-one (531) Food Vendors, Butchers, and School feeding Contractor in the Municipality to sensitize them on proper nutrition/balance diet, mode of transmission of faeco-oral diseases and diseases associated with storage, preparation, handling and sale of food and meat. Health screening exercises were as well organized for all food and meat handlers in the Municipality to ensure that those involved in food, drinks, and meat handling are free from pathogenic organism aimed at protecting them and the consumers

ORIENTATIONS, HEALTH SCREENING AND ENVIRONMENTAL EDUCATION

Orientations for school feeding contractors, food vendors, fruit sellers and butchers

During the period, seven orientation sessions were organized for one thousand, four hundred and ninety (1,490) food vendors butchers and school feeding caterers in the municipality to sensitize them on proper nutrition/balance diet, mode of transmission of faeco-oral diseases and diseases associated with storage, preparation, handling and sale of food and meat.

Health screening exercise

Health screening exercises were as well organized for all food and meat handlers in the Municipality to ensure that those involved in food, drinks, and meat handling are free from pathogenic organism aimed at protecting them and the consumers.

Foods, drugs, water safety and hygiene unit

This unit is responsible for the monitoring of all food, drugs and water hygiene and safety activities including activities of School Feeding, all industries/institutions as well as controlling and management of the main slaughter house and the market.

It collaborated effectively with Municipal Education Directorate, food and drugs authority, Ghana standard Authority, market women association and butcher's association in addressing relevant issues of mutual concern

ENVIRONMENTAL EDUCATION

Orientations for school feeding contractors, food vendors, fruit sellers and butchers

During the period, six orientations were organized for One Thousand, Three Hundred and Six (1,306) food vendors, butchers in the municipality to sensitize them on proper nutrition/balance diet, mode of transmission of faeco-oral diseases and diseases associated with storage, preparation, handling and sale of food and meat. Health screening exercises were as well organized for all food and meat handlers in the Municipality to ensure that those involved in food, drinks, and meat handling are free from pathogenic organism aimed at protecting them and the consumers.

Orientations for school feeding contractors, food vendors, fruit sellers and butchers

During the period, seven orientation sessions were organized for one thousand, four hundred and ninety (1,490) food vendors butchers and school feeding caterers in the municipality to sensitize them on proper nutrition/balance diet, mode of transmission of faeco-oral diseases and diseases associated with storage, preparation, handling and sale of food and meat.



The daily market is provided with two meat shops whilst the weekly market (Bosoma Market) had one






ENVIRONMENTAL AND HEALTH PROMOTION UNIT

The unit did intensive education from house to house and on all the radio stations in the municipality. Programmes carried out included:

- Orientation to 2,000 food and drinks handlers
- Nutritional Intervention Programs
- Good nutrition for school feeding caterers
- Prevention of cholera
- Personal hygiene process
- Oral health

Food and water hygiene practices
CLTS (construction of household toilets)

The Department embarked on intensive Health Educational campaign and rigorous law enforcement on compliance of sanitation and hygiene principles as well as establishing sanitation clubs in Three (3) basic schools within the municipality on relevant public health topics including cholera prevention.

MICRONUTRIENT DEFICIENCY CONTROL

Micronutrients are vitamins and minerals that are needed to maintain strong bodies and mental sharpness fight off diseases and bear healthy children. Three of these micronutrients (vitamin A, iron and iodine) have been found to affect child survival, women's health, educational achievement, adult productivity, and overall resistance to illnesses. Their deficiencies present serious public health problems for the country. Supplementation programs are therefore carried out all over the various health facilities within the municipality among the most vulnerable groups (women and children) and adolescents

➤ **GIFTS – Administration of Iron-Folates to girls 10-19 years weekly.**

In all, one thousand two hundred and ninety-four (1,294) Girls had the Iron Folates Tablets Supplementation. An orientation is always given before they are administered.

The main goal of the unit is to promote early preventive strategies, healthy behaviors and wellbeing, through the creation of environments where individuals, families and communities are informed, empowered and lives healthier happier lives to improve the health of the people in the Municipality and the nation at large.
